Environmental Litigation: The Expert Witnesses View

Paul Adam is an Associate Professor in the School of Biological Earth and Environmental Sciences, UNSW. His areas of research include wetland and rainforest ecology. Currently he is chairperson of the Scientific Committee established by the Threatened Species Conservation Act 1995 (NSW). He has appeared as an expert witness in a number of jurisdictions, and appeared in various cases before the Land and Environment Court of NSW.

In this seminar Paul Adam will discuss the problems that beset the expert witness in dealing with legal processes, and his view of how well the adversarial system of litigation works in producing optimal outcomes for the objectives of environmental law and policy.
